#### Dr. Laura Cabrera

CO-FOUNDER AND CEO OF CABRERA RESEARCH LAB

Dr. Laura Cabrera (B.S., M.P.A., Ph.D., Cornell) is the Board Chair and Professor at the Systems Thinking Standards Institute (STSI)™, where she leads the development of global systems thinking standards. She is also Co-Founder and CEO of Cabrera Research Lab and teaches at Cornell University, where she directs the Graduate Certification Program in Systems Thinking, Modeling,

and Leadership. With over 25 years of experience in research and education, Dr. Cabrera has contributed extensively to public policy, systems science, and practical applications of systems thinking. She is the co-author of six books, including *Connect the Dots* and *Systems Thinking Made Simple*, and serves as co-editor of the *Journal of Systems Thinking*.



#### Martin Hacala

CEO AND PRESIDENT OF GENESIS AND GENSTAR

Martin Hacala is President and Chief Executive Officer of GenStar and Genesis. He assumed the leadership of GenStar and Genesis in 2015. Previously, Marty held a variety of senior underwriting and claims positions in GenStar, Genesis, and Gen Re. ### Dr. Carl Marci

CHIEF CLINICAL OFFICER AND MANAGING DIRECTOR OF MENTAL HEALTH AND NEUROSCIENCE AT OM1

Dr. Marci is a physician, scientist, entrepreneur, and author of the book, *Rewired: Protecting Your Brain in the Digital Age* (Harvard University Press, 2022). He is currently the Chief Clinical Officer and Managing Director of Mental Health and Neuroscience at OM1, a venture backed health technology and AI company based in Boston, MA. He is a board-certified psychiatrist, part-time faculty at Massachusetts General Hospital and Assistant Professor of Psychiatry at Harvard Medical School. He also advises several investment groups and early-stage health tech companies.

Previously, Dr. Marci was Chief Psychiatrist and Chief Medical Officer at a number of early-stage venture backed health and technology companies and he is the co-founder and former Chairman and Chief Executive Officer of Innerscope Research, a pioneer in the field of consumer neuroscience. Innerscope Research was a data science and media research firm acquired by Nielsen in 2015, where he served as executive vice president and the first Global Chief Neuroscientist until 2019.

Bill is Chairman and CEO of NEAM, Inc. and a member of the Firm's Policy Committee. He joined the Firm as Vice President in 2000, was made President in 2010 and became CEO in 2014.
