Greg Lindsay is an urban tech fellow at Cornell Tech's Jacobs Institute, where he explores AI and augmented reality at urban scale. He is also a senior fellow of MIT's Future Urban Collectives Lab, a senior advisor to Climate Alpha, and a non-resident senior fellow of the Atlantic Council's Scowcroft Strategy Initiative.

He's been cited as an expert on the future of cities, technology, and mobility by The New York Times, The Washington Post, The Wall Street Journal, CNN, NPR, and the BBC. He's advised Intel, Samsung, IKEA, Starbucks, Audi, Hyundai, and numerous G20 government entities. He was previously the urbanist-in-residence at URBAN-X — BMW MINI's urban tech accelerator — the director of applied research at NewCities,

and founding director of strategy at its mobility-focused offshoot CoMotion.

He speaks frequently about cities, mobility,

innovation, and globalization, including appearances at 10 Downing Street, the United States Military Academy, Sandia National Laboratories, the OECD, Harvard Business School, the MIT Media Lab, and the Aspen Ideas Festival. His work with Studio Gang Architects on the future of suburbia was displayed at New York's Museum of Modern Art (MoMA) in 2012.

Greg is a two-time Jeopardy! champion (and the only human to go undefeated against IBM's Watson).
